

II MEMBERSHIP AND SUBSCRIPTIONS

6 MEMBERSHIP

6.1 Coverage

- (a) Membership of the Association shall be open to any person who is employed or engaged to be employed in New Zealand as:
- (I) a salaried medical practitioner
 - (i) other than as
 - a final year medical student
 - a resident medical officer
 - a Family Medicine Training programme trainee
 - a trainee intern
 - university medical staff
 - a university student health doctor
 - a medical practitioner employed by a government department
 - a medical officer of special scale who is participating in a resident medical officer roster
 - any other person who has not already obtained specialist qualifications employed or engaged to be employed in any training scheme recognised by a specialist college throughout New Zealand.
 - (ii) who is registered with the Medical Council of New Zealand.
 - (iii) who holds a current practising certificate and
 - (iv) who is recognised as a medical practitioner under the Medical Practitioners Act 1968, its amendments, and subsequent amending legislation.
 - OR (II) a salaried dental practitioner
 - (i) other than as
 - a dental house surgeon
 - a dental registrar
 - university dental staff
 - a dental practitioner employed by a government department.
 - (ii) who is registered with the Dental Council of New Zealand.
 - (iii) who holds a current practising certificate and
 - (iv) who is recognised as a dentist under the Dental Act 1988, its amendments, and subsequent amending legislation.

(b) Any person who has been within the description set out in sub-rule 6.1(a) of this Rule and who intends to resume a salaried medical or dental position pursuant to a provision in an award, agreement or contract of service, but who is for the time being:

- (i) on secondment to any other position or organisation;
or
- (ii) taking any period of leave where that period of leave or any part of that period is not paid leave; or
- (iii) not actively engaged in medical or dental duties pursuant to a provision in an award, agreement or contract of service:

may continue to be a member of the Association for a period not exceeding 3 years.
